## IEP and 504 plans



## An overview for parents and other care providers

An individualized education program (IEP) and 504 plan give formal help to students with learning and attention needs. Both plans are open to students in kindergarten through 12<sup>th</sup> grade. Use this chart to compare the plans.

	IEP	504 plan
What is it?	An IEP is a plan for a child's special education experience at school.	A 504 plan is a plan for a child's access to learning at school.
What does it do?	An IEP gives special education that is unique to each child. It also gives other services (such as therapies and adaptive physical education) to meet the needs of each child.	A 504 plan gives changes to the learning setting to meet the needs of each child.
Who is eligible?	<ul> <li>A child is eligible for an IEP if:</li> <li>He has one or more of the 13 disabilities listed in IDEA. Learning and attention needs may qualify.</li> <li>His disability affects his educational performance.         His disability affects his ability to learn and benefit from general education.     </li> </ul>	<ul> <li>The 504 plan has a more broad definition of disability. Some children who do not qualify for an IEP may still be able to get a 504 plan. A child is eligible for a 504 plan if:</li> <li>He has any disability. This may include learning or attention needs.</li> <li>His disability affects his ability to learn in a general education classroom.</li> </ul>
Independent educational evaluation	Parents can ask the school district to pay for an independent educational evaluation by an outside expert. The school district does not have to pay for one.  Parents can pay for an outside evaluation on their own. The school system may not honor it.	Parents are not allowed to ask the school district for an independent educational evaluation.  Parents can pay for an outside evaluation on their own. The school system may not honor it.
Who makes the plan?	An IEP team makes the child's IEP plan. The team must include:  The child's parent  At least one of the child's general education teachers  At least one special education	A team of people who know the child make the 504 plan. 	The IEP sets learning goals for a child. It goes over the services the school will give the child.  The IEP must include:  How the child is currently doing in school.	There is no standard 504 plan. Unlike an IEP, a 504 plan does not have to be in written form.  In general, a 504 plan includes:  • Specific changes, supports or services for the child.
What is in the plan?	<ul> <li>Yearly education goals for the child.</li> <li>How the school will track the child's progress.</li> <li>The services the child will get. This may include special education and extended school year services.</li> </ul>	<ul> <li>The names of who will give each service.</li> <li>The name of the person who will make sure the plan is started and followed.</li> </ul>
	<ul> <li>The timing of services. This may include when services start, how often they occur, and how long they last.</li> <li>Any changes to the child's learning setting.</li> </ul>	
What do parents need to do?	The school must tell parents in writing when they want to change a child's services or placement. This is called prior written notice.  A parent must give written consent for the school to evaluate their child. Parents must also give written consent before the school can give services in an IEP.	The school must tell parents about a major change in placement. Notice does not have to be in writing. Most schools give written notice anyway.  A parent must give consent for the school district to evaluate their child.
